Booking is available only if:

1- upon receipt of deposit equal to 30% of the total amount of the stay which will be deducted from the total amount of your stay to be paid before departure.

2- only after confirmation from us after studying our schedule.

No reduction or refund will be applied in the event of late arrival or early departure.

The deposit will be retained if the possible cancellation of your stay is not announced by registered mail with acknowledgment of receipt at least 30 days before the start date of the stay indicated on the reservation contract..

The reserved space is available from 12 noon on the day of arrival and must be vacated no later than 12 noon on the day of departure.

In case you have to delay your arrival, please let us know. Otherwise, the site will remain free until 12 noon the next day, and we will keep the deposit.

The information collected on this contract is recorded in a computerised file by the town hall of Rougon for the management of the booking and rental contract of the Verdon Carajuan municipal campsite, the municipality of Rougon also keeps the data in paper version. The legal basis for this processing is the contract. Some of the data collected is transmitted only to the public treasury for the management of the payment of the reservation and the rental. We only store your data for as long as is necessary for the purposes pursued, in accordance with the legal requirements and archival rules of local authorities. Users have the right to information, access, rectification, limitation and portability of all their personal data.
